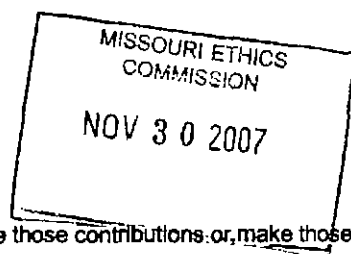
13. STATEMENT OF REPORTING EXEMPTION
