MISSION

MEC serves the public interest by assisting and educating the citizens of Missouri, public officials, lobbyists and individuals participating in public elections, while consistently and uniformly enforcing campaign finance, conflict of interest and lobbying laws.

Personal Financial Disclosure (PFD)

Political Subdivisions Reminders

Annual Operating Budget (AOB)

In order to identify those persons required to file a PFD, every political subdivision must indicate whether their AOB is:

- Over \$1 million; or
- \$1 million or under

If your AOB is \$1 million dollars or under, there are no requirements for employees or elected officials to file a PFD.

If your AOB is over \$1 million, you may choose to adopt an ordinance, order or resolution identifying who must file a PFD, or follow the law for required filers (§105.483 RSMo.). A list of required filers is submitted in the fall of each year.

How to file AOB:

- Submit Electronically
 - I. Go to our website
 - 2. Log into the <u>Political Subdi-</u> <u>vision Filing System</u> (use your political subdivision's log-in information)
 - Update subdivision contact information (if necessary)
 - Confirm AOB (you will receive an email confirmation)
- File by Paper
 - 1. Complete fillable form on our website & print; or
 - 2. Print blank form & complete
 - 3. Mail or hand-deliver form to MEC

Conflict of Interest Ordinance/Resolution

JULY 2011

If your ordinance expires this year and you wish to keep it in effect, you must, by **Sept. 15th**, re-adopt it at an open meeting. Within 10 days of adoption, you must mail a certified copy to our office.

See $\frac{105.485 \text{ RSMo.}}{1000 \text{ RSMo.}}$, for minimum ordinance requirements. You may also wish to consider the following:

- Penalties for failure to follow ordinance
- Filing requirements for candidates

If you do not re-adopt the ordinance, all elected, appointed, and decision making personnel, as well as candidates, will be required to file a PFD.

PACS are formed to support or oppose ballot measures and/or candidates over multiple elections. From our website, select "Campaign Finance", under Campaign Finance Searches... Ballot Measure/Campaign Specific...select "Ballot Measures-PAC Expenditures"
