## Clerks and local election authorities: Take steps to prepare for 2025 elections.

Candidate filing for the April 8, 2025, municipal election begins December 10, 2024. Clerks and local election authorities should complete the following steps to help the process run smoothly:

- Know whether your political subdivision's annual operating budget exceeds \$1 million. This will help the subdivision determine which candidates must file a PFD.
- Review your subdivision's conflict of interest ordinance (if applicable).
- Review election packets from the MEC. Ensure the subdivision has sufficient and correct materials.
- ✓ Inform candidates whether they must file a PFD by completing a Notice to Candidate Form with every candidate.
- ✓ Distribute MEC materials to candidates, including a copy of the completed Notice to Candidate Form, a paper PFD form (if candidate is required to file), a 2025 Ethics Guide, campaign finance publications, and MEC Training Flyer.

## Campaign Finance: Post-Election Guidelines

#### **Guidelines for unsuccessful candidates:**

If the committee has more money on hand than debt, it must terminate within 30 days of the election (December 5, 2024). See our <u>Terminating a Committee Information Sheet</u> for details.

If the committee has more debt than money on hand, it may file an amended Statement of Committee

Organization to convert to a debt service committee.

Debt service committees must terminate within 30 days of dissolution, but no later than 18 months after conversion.

#### **Guidelines for successful candidates:**

A candidate may not take office or be sworn in until the committee has filed all campaign finance reports required by law. Therefore, successful candidates must file a 30 Day After Election Report before being sworn-in (if required).

Successful candidates may keep their committee open and active. Such committees should <u>file an amended Statement of Committee Organization</u>, updating their election date to continue receiving timely, relevant reporting reminders.

Remember, for candidate committees, contributor aggregates and contribution limits run over the course of an election cycle. Once your general election concludes, your committee may begin accepting contributions for your next election cycle.

#### **Guidelines for campaign committees:**

Campaign committees must officially terminate their committee the later of 30 days after the election or upon the elimination of all committee debt. See our <a href="Terminating a Committee Information Sheet">Terminating a Committee Information Sheet</a> for details.

### Lobbyists: Renew your registration for 2025

Missouri lobbyists must annually renew their registration with the MEC and pay a \$10 renewal fee. Renew your registration between December 1, 2024, and January 5, 2025, for calendar year 2025. If your lobbyist renewal and payment is not complete by January 5, your lobbyist status will be terminated, effective December 31. To renew your registration:



Log in to the lobbyist electronic filing system.



**Starting on December 1, 2024, a registration renewal prompt will appear at the top of the screen.** Click the prompt link to begin. Review your lobbyist information and make any changes, if necessary. Once everything looks correct, click "Agree."



**Pay your \$10 registration renewal fee.** You will be directed to a secure vendor to pay electronically, but you may choose to mail a check or money order to the MEC (PO Box 1370, Jefferson City, MO 65102) or drop off your payment in-person or using our drop-box (3411 Knipp Drive, Jefferson City, MO 65109).
